Overall purpose of the job

Reablement Support Workers provide individualised, transformative care in an enabling way. They work to individualised goal plans which are changed as people improve. Support Workers are trained to assess for and to provide some assistive equipment to assist service users. Support Workers receive training about mental capacity, diversity, dementia, dignity, health.

Support Workers deliver care on behalf of Cambridgeshire County Council and are required to be good representatives of the Council.

The role is critical in achieving good service results.

Main accountabilities

	Main accountabilities
1.	Delivery of enabling support and personal care to a range of people in vastly different circumstances. This involves provision of personal care, such as washing, dressing, toileting, shaving, mouth care, catheter care, feeding and meal preparation. This is not an exclusive list. It is expected that staff encourage and support people to do these things for themselves, wherever possible. It also includes helping service users to improve or maintain their mobility through exercise and the use of mobility appliances or fitting equipment if appropriate.
2.	Review and recording of achievement re goals with service users.
3.	Feedback information to senior staff in regard to service user ability and progress in order to inform decision making.
4.	Accurate, literate recording. Notes may be used as evidence in legal challenge and need to stand some scrutiny.
5.	Completion of risk assessments. This involves making the decision as to whether this is appropriate and on the course of escalation of a range of issues.
6.	Support Workers provide some end of life care as CCC representatives.
7.	To be trusted assessors for assistive tech equipment. To assess for ability re showering, employing rails seats and basic equipment.
8.	Participate in the training, supervision and appraisal processes in accordance with CCC policy.
9.	To work in line with CQC standards re human rights, diversity and mental capacity.
10.	Liaise effectively within the team and service partners as appropriate to ensure the service is delivered effectively.
